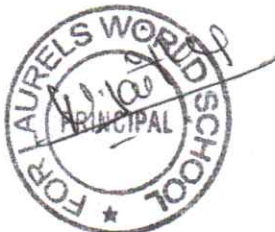

राज्य शासन एतद् द्वारा अशासकीय संस्था-लौरेल वर्ल्ड स्कूल, ग्राम जमुनिया छीर भोपाल, जिला-भोपाल, म०प्र० को सी०बी०एस०ई० नई दिल्ली से सम्बद्धता हेतु अनापत्ति प्रमाण पत्र निम्नलिखित शर्तों के आधार पर प्रदान किया जाता है:-

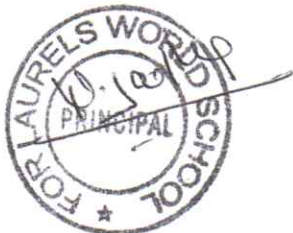
- (1) केन्द्रीय माध्यमिक शिक्षा मण्डल या अन्य बोर्ड से सम्बद्धता मिलने के उपरांत भी मध्यप्रदेश माध्यमिक एवं उच्चतर माध्यमिक शालाओं की मान्यता नियम, 2017 में दिये गये प्रावधानों का पालन किया जावेगा।
- (2) विद्यालय प्रबंधन द्वारा विद्यालय की प्रबंधन समिति में संभागीय संयुक्त संचालक, लोक शिक्षण तथा उनके द्वारा नामांकित एक प्रतिनिधि को सदस्य के रूप में नामांकित करना होगा तथा प्रबंधन समिति की बैठकों में शासकीय सदस्य की उपस्थिति अनिवार्य होगी।
- (3) संस्था द्वारा प्रवेश संबंधी नियम प्रक्रिया तथा निर्धारित शुल्क यथा-समय प्रकाशित किये जायेंगे। शिक्षण शुल्क लेने में पालकों का शोषण नहीं किया जायेगा।
- (4) संस्था विभिन्न अवसरों पर छात्रों के आयोजित होने वाले सांस्कृतिक एवं खेलकूद कार्यक्रम तथा अन्य छात्र-शिक्षकों की गतिविधियों के लिये खेल का मैदान, छात्रावास भवन की सुविधा आदि आवश्यकतानुसार उपलब्ध करायेंगे। इस हेतु संस्था से वचन पत्र लिया जाये।
- (5) संस्था द्वारा प्रदेश के खेल आयोजनों, सांस्कृतिक आयोजनों, विज्ञान मेला आदि के आयोजन में सहयोग एवं सार्थक भूमिका प्रदान की जावेगी।
- (6) निःशक्त छात्रों के लिये संस्था को रेम्प की व्यवस्था करना आवश्यक होगा। संस्था निःशक्त छात्रों को प्रवेश देने से इन्कार नहीं करेगी। इस संबंध में प्राप्त शिकायत यदि सिद्ध पाई गई तो संस्था का अनापत्ति प्रमाण पत्र समाप्त करने की कार्यवाही की जा सकेगी।

- (7) छात्र-छात्राओं को शालाओं में लगने वाली पुस्तके एवं लेखन सामग्री खुले बाजार से कय करने की सुविधा रहेगी। किसी दुकान विशेष से कय करने की बाध्यता नहीं रहेगी।
- (8) संस्था के छात्रों को उनके निवास से विद्यालय तक लाने एवं वापिस भेजने के लिये परिवहन विभाग द्वारा दी गई अनुमति प्राप्त एवं वैद्य वाहनों का ही उपयोग किया जायेगा। छात्रों की सुरक्षा की दृष्टि से इस हेतु उपयोग किये जाने वाले वाहनों को किसी भी ऐसे ज्वलनशील साधन जैसे घरेलू एलपीजी आदि से संचालित नहीं किया जायेगा।

- (10) छात्रों की सुरक्षा तथा परिवहन के संबंध में स्कूल शिक्षा विभाग व परिवहन विभाग द्वारा समय-समय पर जारी निर्देशों का पालन करना होगा।
- (11) संस्था के पुस्तकालय में जाति एवं धर्म के आधार पर भेद-भाव तथा साम्प्रदायिकता को बढ़ावा देने वाली किन्हीं पुस्तकों का संग्रहण नहीं किया जायेगा और भारत सरकार एवं मध्यप्रदेश शासन द्वारा प्रतिबंधित पुस्तकें भी नहीं रखी जा सकेगी।
